

These updates are intended to provide you with the latest information about remediation, restoration and redevelopment activities at the Milltown Reservoir Superfund Site.



<u>Status</u>: The Milltown Project continues to go very well and is on schedule.

Project personnel have worked a total of 341,850 hours without time lost to injury (2/14/2010).

### Remediation and Restoration and Redevelopment

- Completed Grading Plan work in Sediment Accumulation Area III-b
- Completed placement of rip rap Tunnel Pond buttress. The Tunnel Pond Repository was an existing on-site repository and was expanded to hold excavated material from the project area, including the SAA-IIIb sediments.
- Completed excavation of Sediment Accumulation Area IV sediments.

  These sediments were used to provide a cover for the Tunnel Pond repository.

  The repository will be seeded this spring.
- Reclamation work has begun on the Two Rivers Park area owned and operated by the Bonner Development Group (BDG). Clean soils stockpiled on the Missoula County Sheriff's Posse Grounds are being hauled to the Two Rivers Park area for re-grading. The BDG Board of Directors toured the site, discussed and approved the reclamation plan for that area.
- The Agencies have approved the final Operation and Maintenance Plan for the on-site repositories and the Remedial Action Monitoring Plan (RAMP). The O&M plan describes how the repositories will be monitored to ensure that the cleanup continues to be protective of public health and the environment. This plans covers the Tunnel Pond repository, the right bank repository (near the former site of the Powerhouse) and the Upland Disposal Area (an existing repository that was not modified during cleanup activities). The RAMP describes what monitoring will be done during the time between "Substantial Completion" of remedial activities and when the removal and regarding of the Clark Fork River Bypass Channel begins.

# On-going and Upcoming work:

- EPA and the State have received the request from Environ (on behalf of the Settling Defendants, Atlantic Richfield and NorthWestern Energy) seeking approval of "Substantial Completion" of Remedial Action. The Agencies are currently considering this request.
- FWP has placed fish cages in Clark Fork and Blackfoot Rivers for monitoring
- FWP will be radio-tagging fish in April and conducting annual estimates of fish populations in June
- Continue groundwater and well monitoring;
- Redevelopment/Park planning continues— Two NRDP grants and federal funding awarded for Milltown area work.
